

**Assumption of Risk and Waiver of Liability  
Relating to Coronavirus/COVID-19  
Reservations for Caroline County Facilities, Parks, or Athletic Fields**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Caroline County Parks and Recreation Department has created new protocols and put in place preventative measures to reduce the spread of COVID-19; however, the County cannot guarantee that you will not become infected with COVID-19. Further, attending any program may increase your risk of contracting COVID-19, and may increase the risk of transmitting COVID-19 to others.



I acknowledge the highly contagious nature of COVID-19 and voluntarily assume the risk that I, or members of my group or organization, may be exposed to or infected by COVID-19 by participating in any way in any event, program, activity, reservation or rental taking place at a Caroline County recreation facility or park, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at a Caroline County recreation facility or park may result from the actions, omissions, or negligence of myself and others, including, but not limited to, County employees, volunteers, and other participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself or members of my group or organization, including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind, that they or I may experience or incur in connection with participation in any event, program, activity, reservation or rental taking place at a County Parks and Recreation facility. I hereby release, covenant not to sue, discharge, and hold harmless Caroline County, its employees, agents, and representatives, of and from any claims related to COVID-19, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I further agree to indemnify and hold harmless Caroline County and its employees, agents, and representatives from any claim that may arise from or in connection with my or members of my group or organization's participation in any program taking place at a Caroline County Parks and Recreation facility, including claims related to COVID-19.

I further certify that I have reviewed the COVID-19 Guidelines that have been provided to me and, that as the authorized representative, I certify that we will create a plan to adhere to these guidelines during every use.

This plan must include, but may not be limited to, the following standards:

- Temperature screening of program participants and/or rental guests upon entrance to the facility, park, or field.
- Access denied to those guests/program participants with temperature readings at or above 100.4 degrees
- Mask coverings in use always while inside a building or within 6 feet from the next person while outside except while eating/drinking or if medical conditions require periodic breaks.
- Periodic cleaning of bathroom areas for rental events that exceed 2 hours.
